LEARNING OBJECTIVES+

The overall objective of this course is to give you an introduction to cognitive behavior therapies, and to help you apply these techniques if you want to change something about yourself. Thus, we will discuss how these therapies can apply to everyone. This course is not intended to make you a therapist. The specific learning objectives+ of the course are for you to learn about:

- 1) The history, theories, and applications of cognitive therapies+, and
- 2) The history, theories, and applications of behavior therapies+.

GUEST SPEAKER

Three guest speakers are scheduled. You will be required to write **one full single-spaced-**page opinion essay about each speaker's presentation. Each essay will be worth 10 points. The essays should consist of your opinions about each presenter—what you liked or disliked, and why. The essays should not be a summary of the presentation. The essays must be written in Times New Roman font and size-12 font. Spacing between the lines should be 1.0. Points will be deducted if the essay does not adhere to these requirements. The assignments are to be given to me as a hard copy. The essays are due one week after the respective guest speaker's presentation. **Late and e-mailed essays will not be accepted**.

VISIT TO DISMAS CHARITIES HALFWAY HOUSE

A visit to Dismas Charities [El Paso's federal Bureau of Prison's (BOP) reintegration center at 7011 Alameda] is tentatively scheduled for Wednesday, March 6 at 5:30. The visit will consist of a tour of Dismas and presentations by residents who completed a drug program during their incarceration and by staff. The visit is on a voluntary basis. Students who go will have to sign a waiver form prior to the visit, which is available in Blackboard under the title of "Waiver Dismas Charities."

CLASS DEPORTMENT

I want all of you to succeed in the course, and I do many things to help you do so. Two very strong impediments to succeeding are the use of cellular phones and sleeping during class. EXAMS AND GRADES

There will be five tests, each consisting of 40 to 60 multiple-choice questions. Each test will be worth 100 points. I will keep the exams in my office for 14 days+ so you can review your answers and improve your test performance. The syllabus contains important information about the course, so it is important for you to read it. There will be questions about it on each test on information that has a +. Test questions will come from lectures, discussions, the textbooks, films, and from the guest speakers' presentations.

Your course grade will be the addition of the five exams (500 points) plus 10 points for each guest speaker's opinion essay (30 points), for a maximum of 530 points, divided by 5.3 (If one speaker cancels, the sum will be divided by 5.2, and so forth).

Your grade for each exam and for the final grade will be based on the following scale: F = 0 - 59% D = 60 - 69% C = 70 - 79% D = 80 - 89% D = 80 - 100%

Under no circumstances (unless you are deployed by the military or you have a documented medical emergency) will the final exam be given at another day. Makeups for all exams may consist of **open-ended questions**+ and will be given **only** with documented medical **emergencies** or documented military deployment.

Please go to the bathroom before the exam as you will not be permitted to leave the classroom once the exam has begun+. No student will be allowed to enter the classroom once a student has finished an exam and has left the classroom+.
