Course Objectives

Performance Ensemble: This ensemble will develop more original content by composing, arranging, and adapting music. I will have more control of the music that is selected and will be more demanding of the students in this ensemble. This ensemble will rehearse more than the required class time and may perform on and off campus multiple times throughout the semester. As of now, the only performance date set is the recital on Nov. 29th. Students selected for this ensemble will display leadership skills, will be able to work independently and collaboratively, will be able to create music through improvising, arranging and composing, and will be able to contribute something unique to the ensemble. Students will be expected to produce and promote all performances.

You will be graded on your preparedness and conduct at performances and rehearsals. There may be other assignments given throughout the semester.
