I, Johana Rocha, agree to provide supervision to you for the purposes of fulfilling your practicum course requirements of your master's program in Counseling at The University of Texas at El Paso (UTEP).

I am a Doctor in Education with a concentration in Counselor Education and Supervision. I hold a master's degree in Clinical Mental Health Counseling from Old Dominion University (ODU) in Norfolk, VA. Throughout my master's studies, and for a period of 1.5 years, I interned at Chesapeake Regional Healthcare in Chesapeake, VA. While there, I provided counseling services to patients with a range of diagnosis in the Emergency Department, and the medical units to include the Clinical Decision Unit, the Progress Care Unit, and the Intensive Care Unit. Additionally, I conducted therapy at the Transitional Care Clinic to patients with congestive heart failure, chronic obstructive pulmonary disease, no primary care provider, and/or no insurance. Last, I launched an out-patient therapeutic program which provided individual and group services to patients at the Chesapeake Regional Healthcare's Out-patient Cardiopulmonary Rehabilitation Center. In addition to my counseling role, I mentored practicum students in acclimating to the hospital's site, systems, patient and family protocol, and care team procedures. As a doctoral student, I went back to Chesapeake Regional Healthcare and accepted a position as the Associate Director of Behavioral Health during my practicum and internship. I provided therapy to patients/clients in the in-patient and out-patient units. In addition, I provided university and site supervision to practicum students in the mental health counseling master's program at ODU.

It is your responsibility to meet the specific course content requirements and complete the supervised field experiences necessary to meet the requirements of your CACREP Accredited Master's Program at UTEP. You must complete and submit all materials required by your program. I will complete required forms related to supervision of your practicum experience. The supervision I provide to you will include group and individual supervision. You will meet with me for at least 1.5 hours per week for group supervision and twice for 30 minutes for individual supervision during the time you are completing your practicum class. Our professional relationship will involve the scheduled hours for your supervision. I will respond emails within 24 hours during weekdays.


My philosophy and goal as a supervisor are to collaborate with you in helping you to develop into an effective professional through nurturing behaviors and attributes that are in tune with the professional practices of the field. To be effective professional helpers, I would like supervisees to display aspects such as commitment to protecting clients' well-fare; understanding and practice of behaviors that help them make the most out of the supervision experience; ongoing education and increase of cultural competencies; practices that obey the standards and ethics of the profession; facilitation of positive relationships that are genuine and empathic; bilateral engagement in use of positive, difficult and critical

feedback; and self-awareness and reflection about this feedback to improve competency. Accessibility and flexibility are also essential elements of my philosophy, given that these not only enhance the supervisory relationship, but also promote supervisees' sense of support, motivation, and appreciation.

In order for me to supervise you, you must be able to provide me with videotapes for review when assigned. I will keep information revealed in the tape confidential and will review the tape prior to our supervision meeting. During the time I am serving as your supervisor, I will make every effort in collaborating with you to review the cases that you choose to bring to our group supervision. My duty to you is to provide you with professional clinical supervision. However, I will not be responsible for your day to day activities during your practice sessions.

At the end of the semester, I will provide you with a written evaluation of your progress and performance, including my determination of whether you are progressing satisfactorily toward your goal of becoming a professional counselor. I agree to provide clinical supervision to you in a professional manner to the extent described within this agreement. Our relationship is limited to the terms and conditions set forth herein. In our work together, I will adhere to the Ethical Standards for Counseling Supervisors as well as the ethical standards of the American Counseling Association and National Board for Certified Counselors. I will expect you also to operate according to accepted ethical standards for professional counselors.
