## Course Catalog Description

Introduction to advanced concepts and algorithms in data science and their applications. Topics may include deep learning, speech processing, language processing, data integration, information retrieval, and information visualization. May be repeated for credit when topic varies.

## Learning Outcomes

### Course Outcomes

Divided into the following three broad levels of Bloom's taxonomy:

#### Level 1: Knowledge and Comprehension.

Level 1 outcomes are those in which the student has been exposed to the terms and concepts at a basic level and can supply basic definitions. The material has been presented only at a superficial level. Upon successful completion of the course, students will be able to:

- 1a. Describe and compare data models (e.g., Entity-Relationship model, ontologies) and how they are currently used for data integration.
- 1b. Identify current challenges in data management, in particular, aligning with the FAIR principles (Wilkinson et al., 2016).
- 1d. Describe technical solutions to the challenges in data management related with the FAIR principles.
- 1c. Identify current trends in data science research, both fundamental and in application domains.
- 1e. Identify the careers/roles associated with data scientists.

### **Level 2: Application and Analysis.**

Level 2 outcomes are those in which the student can apply the material in familiar situations, e.g., can work a problem of familiar structure with minor changes in the details. Upon successful completion of the course, students will be able to:

2a. Demonstrate uses of metadata associated with data on the web.

Use a non-relational query language (e.g., SPARQL) to elicit information from a non-relational database.

2b. Use and extend current cyberinfrastructure for the sharing, integration or exchange of data for a specific domain.

2c. Demonstrate the ability to design applications that solve real-world problems that required integration of data.

2d. Demonstrate the ability to write a technical report and present findings.

2e. Demonstrate the ability to work in teams.

### **Level 3: Synthesis and Evaluation.**

Level 3 outcomes are those in which the student can apply the material in new situations. This is the highest level of mastery. Upon successful completion of the course, students will be able to:

3a. Design a high-level data integration model from a problem statement using standard notation and modeling principles.

3b. Design and implement a tool prototype that enables the integration of data from heterogeneous, decoupled data.

3c. Design and implement an interface proof-of-concept for a data-integration tool applying best practices for privacy, security, and reproducibility of results.

## **Grading**

1. Exams including midterms, final, and quizzes 50%.
2. Project deliveries including assignments and presentations 30%.
3. Active class participation, homework, and activities 20%.

Assignments for this course are assessed according to rubrics. Each assignment will be provided with the corresponding rubric.

## **Required Materials**

A list of readings included scientific papers and book chapters will be provided by the instructor.

Because these activities are designed to contribute to your learning each week, they cannot be made up after their due date has passed. Make-up activities for class participation can only be made up for one unexcused absence in the semester. A 72-hours advance notice may be provided to you via email.
