COURSE DESCRIPTION

The purpose of this course is to introduce the theory and practice of Geographic Information Systems (GIS). Cartographic, database, technical, and scientific issues involved in creating a useful GIS project will be presented. Databases and their analysis is another emphasis in the course. - Data analysis
- Computer cartography versus GIS data structures
- Import data collected by remote sensing and GPS and other sources
- Data analysis tools & procedures
- Web GIS, Field Data Collector, ArcGIS Server & ArcGIS Pro platforms & Web services

COURSE OBJECTIVES OR EXPECTED LEARNING OUTCOMES

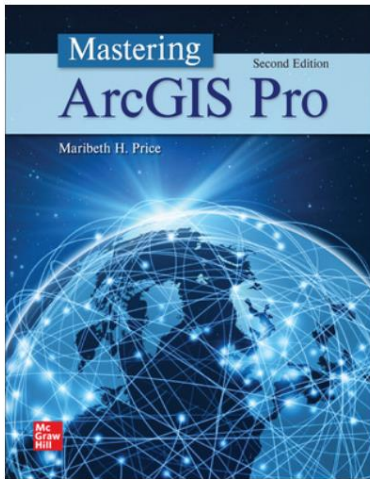
At the end of this course, students will be able to:
