## DETAILS OF COURSE REQUIREMENTS

**I. Discussion Participation:** Each week there will be a discussion that must be answered completely. Your response to the discussion question should be scholarly and thorough. In your response, you must demonstrate your understanding of Textbook readings and the application of the covered materials.

**Initial posts are due by Tuesday, responses to peers are due by Friday at midnight.** *Original posts entered after Tuesday will not be accepted.* See Late work policy. You need to check back to your post as well to make sure you have responded to anyone who may have asked you anything, more so if I have asked you something.

You are required to respond to two students/peers that provokes thought. You must respond with more than “Good job,” or “I agree.” Your response to your peer’s discussion post should provide your understanding or an alternative to your peers’ opinion and the application of concepts.

**Netiquette:** You must maintain an academic attitude and uphold UTEP policies. Being disrespectful, using profanity or unprofessional behavior will not be tolerated. All your online communications must be composed with fairness, honesty, and tact.

**II. PowerPoint presentations- Integrating Theories-** In weeks 2 and 4 you will prepare a PowerPoint presentation, combining and explaining theories that we have examined. The PowerPoint will need to be submitted in Blackboard. See Blackboard for more details.

**III. EXAMS:** You have 3 exams in this class. Each exam is worth 50 points each. The exact format of exams is to be determined. However, the exams will likely be structured with some combination of Multiple choice, True/False, and/or Essay questions. Missed Exams CANNOT be made up.

**IV. Final Theoretical Application:** Case Study of a Sex Offender: Application and understanding of Social Learning Theory and Rational Choice Theory. Students are expected to challenge these theories and provide alternative theories that attempt to explain the behavior of the case study.
