

Identify and explain the function of the major organs involved in the digestion and absorption of food 4. Identify and describe the physiological function, sources, and requirements for major nutrients (e.g. proteins, carbohydrates, fats, vitamins, minerals, and water) by our body 5. Identify the different components of a food label; learn how to read and interpret the label information given related to one's own nutritional needs 6. Learn about different nutrients which are positively related to health and identify those that increase risk of developing chronic disease 7. Analyze the relationship between energy balance and weight management 8. Identify the basic principles of food sanitation, safety and food insecurity 9. Identify the principles of optimum nutrition and mindful eating.

Assessment strategies:	<p>Assessments</p> <ol style="list-style-type: none"> Dietary Analysis (DA): Students will complete the Dietary Analysis using Mind Tap Diet & Wellness website. Additional Instruction on this assignment and necessary forms required can be found on Mind Tap and Blackboard. Late work policy: <u>15 points</u> will be deducted for late DA, for every class day that these is late. Exams. There will be a total of <u>5 exams</u>. There will be NO make-up exam if missed. The lowest of the five exams grade will be dropped (final exam will not be dropped). Each exam will be based on material covered since the previous exam. <i>However, one must realize that information in nutrition is cumulative and highly interrelated. Therefore, just because a concept appears on an Exam does NOT mean that it will not appear on future exam or quizzes.</i> Students are strongly encouraged to create their own study guides to organize lecture notes and textbook material to increase comprehension and memory of large amounts of information. Study guides for exams will not be provided by the instructor or teacher assistant. Attendance and Participation:	<p>It is expected that all students enrolled in HSCI 2302 Fundamentals of Nutrition to participate in all instructional activities. Online courses are no different from classroom courses in regards to attendance. Participation is defined accordingly under assignment strategies. Students “attendance” on online courses is defined as active participation on the course as described in the course syllabus.</p> <p>Online courses will have, at minimum, weekly mechanism for student participation, which can be documented by any or all of the following methods:</p> <ol style="list-style-type: none">1. Reading/viewing all course materials to ensure understanding of assignment requirements.2. Participating in engaging discussion with your peers on the discussion boards (grading rubric provided in the “grading information” area of each forum)3. Participating in scheduled Blackboard Collaborate sessions4. Other activities as indicated in the weekly modules5. Submission/completion of assignment and evaluations6. Communication with the instructor <p>Students who do not log on to the course within the drop/add period for the course will be dropped from the course. Students who fail to maintain an active participation in an online course as defined in the course syllabus will be processed in accordance with the university’s current attendance policy.</p> <p>Other Attendance Policy: Class participation is a mandatory component of this course. It is the student’s responsibility to get all assignments and/or class notes. Not knowing about an exam or assignment due date because lack of participation in the course is not a valid excuse.</p>
Reading assignments & Test Proctoring Software:	<p>All assigned readings need to be completed prior to coming to the next scheduled class session. Example: the reading assignments for week 2 need to be completed prior to coming to the week 2 class session.</p> <p>Please review the following guidelines regarding testing:</p> <ul style="list-style-type: none">• The assessments will only be available at the times identified on the course calendar.• You may take the test at any time during the available time-frame window.• A reliable Internet connection is essential to completing the exam. If you must go to a location to take the exam (such as the library), be sure to follow their health and safety requirements.• You have two attempts to take the test. Once the window closes, your answers will be saved, and no changes can be made. The first score saved will be recorded.



	<ul style="list-style-type: none">• Respondus Lockdown Browser will require that all internet tabs are closed prior to the start of the test – only the final exam will be required to use this software.• Respondus Monitor requires a webcam and microphone.• You will be required to show the webcam your student ID prior to the start of the test.• Your face should be completely visible during the test. Blocking the camera will disable the test.• No notes or textbook materials are permitted during the test. Respondus Monitor requires you to take a video of your surrounding area (desk, chair, walls, etc.)• You should not have conversations with other people and/or leave and return to the area during the test.
Class recordings:	<p>The use of recordings will enable you to have access to class lectures and group discussions. during a test;

- Possession and/or use during an exam or home test of materials which are not authorized by the person giving the test, such as class notes, books, or specifically designed “crib notes”;
- Using, obtaining, or attempting to obtain by any means the whole or any part of non-administered test, test key, homework solution, or computer program; using a test that has been administered in prior classes or semesters but which will be used again either in whole or in part without permission of the instructor; or accessing a test bank without instructor permission;
- Collaborating with or seeking aid from another student for an assignment without authority;
- Substituting for another person, or permitting another person to substitute for one's self, to take a test;

Falsifying research data, laboratory reports, and/or other records or academic work offered for credit.

“**Plagiarism**” means the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the unacknowledged submission or incorporation of it in one's own academic work offered for credit, or using work in a paper or assignment for which the student had received credit in another course without direct permission of all involved instructors. Some of your course work and assessments may be submitted to Safe Assign, a plagiarism detecting software. Safe Assign software will be used for review of assignment submissions for originality. The software will help you learn how to properly attribute sources rather than paraphrase.
