<b>Major learning objectives (must be numbered):</b>	<i>By the end of this course, students will be able to:</i> 1. Understand the importance of good nutrition 2. Identify primary goals and objectives as described in <i>Healthy People 2020</i> and <i>Dietary Guidelines for Americans 2015</i> 3. Identify and explain the function of the major organs involved in the digestion and absorption of food 4. Identify and describe the physiological function, sources, and requirements for major nutrients (e.g. proteins, carbohydrates, fats, vitamins, minerals, and water) by our body 5. Identify the different components of a food label; learn how to read and interpret the label information given related to one's own nutritional needs 6. Learn about different nutrients which are positively related to health and identify those that increase risk of developing chronic disease

7. Analyze the relationship between energy balance and weight management
8. Identify the basic principles of food sanitation, safety and food insecurity
9. Identify the principles of optimum nutrition

**Assessments**

1. **Dietary Analysis:** Students will complete the Dietary Analysis using Super Tracker website. Additional Instructions on this assignment and necessary forms required can be found on Blackboard
2. **Case Studies:** There will be a total of 5 case studies assigned during the time of the course; each case study is due each week on Monday at noon starting on the second week of the semester. There will be no-make up assignments or extended due dates.
3. There will be a total of 3 **Exams** and ONE comprehensive final exam. There will be NO make-up quiz or exams if missed. Each exam will be based on material covered since the previous exam. **However, one must realize that information in nutrition is cumulative and highly interrelated. Therefore, just because a concept appears on a quiz or exam does NOT mean that it will not appear on future quizzes or exams.**
4. **Discussion boards** - A total of two discussion boards are available on BB.
  - a. Introduction: use this board to introduce yourself to your classmates
  - b. Fed Up documentary discussion board
5. **Participation-** Will be assessed by the use of Blackboard - Students must log in into the course at least three times per week. Assessment will include but are not limited to:
  - Blackboard Session attendance:** Students must log in into at least one live session during the semester. Live sessions will be made available during different times during the semester to accommodate to a variety of schedules.
  - Mini-Quizzes-** Each week there will be quizzes related to specific topics
6. **Final Exam** is comprehensive and will be available On-line on the day Final exam is schedule according to the University's Calendar. **You will be exempt from taking the Final exam if you score above 95 in all three exams.**

<b>Attendance:</b>	<p>It is expected that all students enrolled in <b><i>HSCI 2302 Fundamentals of Nutrition</i></b> to participate in all instructional activities. Communication with the instructor</li> </ol> <p>Students who do not log on to the course within the drop/add period for the course will be dropped from the course. Students who fail to maintain an active participation in an online course as defined in the course syllabus will be processed in accordance with the university’s current attendance policy.</p> <p><b>Other Attendance Policy:</b> Class participation is a <b>mandatory</b> component of this course. It is the student’s responsibility to get all assignments and/or class notes. Not knowing about an exam or assignment due date because lack of participation in the course is not a valid excuse.</p>

permission of the instructor; or accessing a test bank without instructor permission;

- Collaborating with or seeking aid from another student for an assignment without authority;
- Substituting for another person, or permitting another person to substitute for one's self, to take a test;
- Falsifying research data, laboratory reports, and/or other records or academic work offered for credit.

**“Plagiarism”** means the appropriation, buying, receiving as a gift, or obtaining by any means another's work and the unacknowledged submission or incorporation of it in one's own academic work offered for credit, or using work in a paper or assignment for which the student had received credit in another course without direct permission of all involved instructors.
