For each chapter you will be asked to complete homework problems. Each homework problem assignment is worth 10 points and is open book. For each homework assignment, you will have **2** attempts, and I will get the **highest** score. Each homework closes just before midnight the day it is due.

Quizzes

Ten (10) quizzes will be given throughout the semester. Each quiz is worth five points.

Online course evaluation for extra credit (max 5 points)
